Might not have been proven in Alaska, but used in 3rd world countries

Leveraging will there ever be a multi-community workshop

ANA: will look at other agencies, 20% match cannot be other federal funds

Denali Commission – leverage different funding sources, have a meeting with all the funders at one time if possible, offers to convene and reach out to other entities, teleconference, brain storm

DOE: willing to consider it, request tech assistance through website, may schedule meetings in communities, DOE hasn't done I.H.S before

Is IHS the require RUBA or tie into that process

IHS: yes, when we score projects, if they owe money to other agencies like IRS, it might be seized. Need to make sure the funds will not be seized.

Why doesn't IHS provide funds for water & maintenance systems?

Not allowed, we build facilities, no funding for operation & maintenance

Has been successful in operating w/ other communities

Is there a way to improve update facilities

Sanitation Efficiency Program, clean water program, clean drink water,

State of Alaska also uses that program

Document IHS problem has a health impact

Engineer is assigned to each community

Work with the engineer,

If Alaska tribes are over 40 % of the tribes, and needs and health risks are bigger, why not more funding

of homes w/ no water/sewer, see number of homes

We are competing w// other 12 ISH areas, who complain we get more many, more than the other areas, other tribes think their needs are as great as ours

AK is more expensive & complicated, but there is only a certain amount of funding, but we get a high percentage of it

Of the \$25k grant, is it restricted to cleanup...;

BIA – for any potential environment project to be evaluated by our staff

Schools, state of Alaska, BIA does not have jurisdiction

For backhaul, electronic waste, funding sources to transport recycle material, where can we get assistance?

ANA has funded projects, but it needs to be a team effort, but time-consuming, especially if it needs to be barged, willing to look into that

Brownsfields – can a 2nd class city apply for cleanup reclamation because of it's associated with state of Alaska

Some funding for state loan, case by case basis, contact brownsfields, yes, can be eligible

How can ANTHC help when a project is funded with ISH, city will not take responsibility

ISH: basically said IHS is complicated

Where can the city purchase honey bucket containers, company doesn't make them anymore

ISH – ask engineers with ANTHC, we don't know

BIA grant for environmental projects, how many each year, how much, want summary, name some of the projects

We can only fund when we have enough year-end money

Fed money is less, cannot say how many can be funded, will look at them end of year, if more than \$25k, federal will look at it, if less, we check here

Small communities – management, writing & reports are difficult for staff

What can help communities manage these grants, grant reporting. Aid to Tribal government to help small communities to manage projects? Overwhelming for tribal office or city. NO PRIOR TRAINING, Tribes are in jeopardy because they cannot fulfill reporting requirements.

ANA – has streamlined the reporting – ask for quarterly information. Accountability. Want to make sure your project gets completed. All the reporting systems are different, different agencies should have the same reporting format.

DOE – will try to help, phone, internet. Ask for tech assistance on website; will call it organizational development, want to make sure projects succeed.

Why are we obligated to write the grant if we cannot even spend it. DOE stimulus package grant, we have been reporting. We applied, got notice to do other report for money we haven't received and can't get the money?

There are a couple of ways to draw out the money, other tribes get lost in the system and can't get the money.

Will be back at BIA conference

Where can we get info on money available for environmental projects?

BIA – we have packages,

Schools – there are deserted schools, built in 1950's – contaminated, are there funds for removal and demolition

BIA – no, we're working with state of Alaska

Our water & sewer program is on hold for portion of our community, most of the funding goes to engineering, design

There are 3 areas in Alaska, there are limits. Cheaper in Southeast and more expensive in western Alaska. Limited funding, some projects are infeasible and won't score very well

Design & engineering shouldn't be more than 10%, majority should be spent on construction of the project.

Power plant, storm surge is threatening it, is there funding for emergencies, to move it?

Denali: is it an AVEC community? Denali is not participating in emergency, state programs are for emergencies. We have funding for new facilities or upgrades through USDA. Funding for long-range strategies

Eligible funding, can we use your federal funding as a match for other federal funding

Denali: health program has had 50% and 20% match

Eligibility – some funders will not allow you to use our funds as a match because we use federal money

IHS – yes, there are contribution points, it helps your score

BIA I- projects are on a relatively small scale, there is a matching requirement

ANA – needs to be matching funds, but be creative, like office space, telephone, donated time, like from elders, some have even used BIA638 money

Americorp – cannot use as a match; Can count volunteer time, something like \$20/hour

DOE – no fund match requirements, depends on FOA

EECBG, can you extend the deadline? Now Sept 20

What areas of the state are ideal for renewable energy sources? Wind energy, multi-agency cooperation to do a study of that. Reporting requirements, we are understaffed. Why not put DOE in one website? It's very complicated? Do you have money to help communities prepare to adapt to climate change?

DOE: within 18 months know where it's going, spend it within 3 years,. DOE reporting, obtain your enrollment, trying to minimize reporting. Create your report, have to have a pin number.

Climate change – DOE doesn't have anything to deal with that. You're on the front lines, DC doesn't relate to it. NCAI – climate change. We have grants that are longer term to build projects, but not emergency projects.

Renewable energy authority, check our brochure, solar, wind, biomass... there are grants, measure wind, solar, geothermal
